**Terms of the agreement:**

- I understand that I am being authorized entrance to the Park University residence halls and that services and accessibility are limited.
- I understand that a requirement to stay on campus this summer is to be enrolled in at least one summer class during any summer term.
- I understand that if I am in the halls other than the terms which I have pre-paid I will be charged for the entire term period for which I am here.
- I understand that I am fully responsible for my guests. If their conduct is inappropriate, it will reflect on me. This could result in my dismissal from the hall for the rest of summer occupancy and conduct violation charges.
- I understand that I must abide by all university and residence hall policies and regulations, and comply with all instructions of the residence hall staff. I understand that failure to comply with the provision so the request can lead to this permission being revoked immediately by the Residence Life Coordinator or designee, and my being asked to leave immediately until the residence halls officially open.
- I agree to pay the charges associated for each term listed below. All bills must be paid prior to the start of each term. If I have not paid my bill by the start of each term then I will be assessed a \$25 late payment charge. **Any bill that is not paid by the 10<sup>th</sup> of every month will be considered late. Two delinquent bills will result in eviction for the rest of the summer break.**
- I understand that this charge is for room only. There are no meals available during the break periods, except at designated times. During designated times I do not have a meal plan and will have to pay for meals on my own if I choose to eat in the dining center.
- Rooms in Dearing will be limited to two floors and will be assigned based on the date the Summer Break Agreement is completed and turned in. There is limited space in Dearing and once summer housing is full it is full.
- Students that choose elect to live on campus for all four terms will be given preference over students who choose only one, two, or three terms.
- In the event that there are extra rooms and space available for single rooms, a \$50 charge per single room will be added to each term. Single rooms will be assigned based on availability and return date of agreement.
