STUDENT FITNESS CENTER USE SEMESTER FEE

The student fitness center use semester fee of \$20 is due upon signing of the membership agreement. The total payment is based upon the beginning of the present semester, _____, (semester, year) and ends on the final day of the present semester. Students must pay this fee at the beginning of each semester in which they desire to utilize the fitness center. Payment is due immediately and can be made at the Mackay Hall cashier window.

Renewal Program Options:

RENEWAL STATEMENT PROGRAM:

Provided member is not in default or delinquent of this agreement, member may retain use of all privileges by renewing on or before July 1, _____ at the amount and payment terms specified under the renewed agreement.

AUTOMATIC RENEWAL PROGRAM: (available for auto-deduct payment ONLY)

Provided the member is not in default of this agreement and subject to the terms and conditions thereof, the membership will automatically renew July 1, _____. It is also understood that the University has the option to increase monthly renewal fees without notice during any renewal period.

1. **MEMBERSHIP QUALIFICATIONS.** Non-student members must be 18 years or older and currently employed by the University as a full time or part time faculty and/or staff member. Student membership is designated as all other students who are not classified as Parkville Daytime Home Campus who desire to use the fitness center. Membership does not infer any authority in the management of the facilities or any interest in the property or assets of the fitness center. Memberships are non-transferable. At no time will guests be permitted to use the facilities unless authorized by staff in accordance with a specific class, program, or activity.

2. **PAYMENT.** All payments to the University are non-refundable, subject to refund policies of the University.
A. **Annual Payment:** Under this option, a payment of \$_____ must accompany the signed Agreement.
B. **Monthly Payroll Deduction Payment:** Under this option, a payment of \$_____ will be deducted from Member's payroll. Member agrees that this amount will be deducted each month for the twelve month term of the Agreement through "automatic" Payroll deduction. Member agrees to a minimum membership term of one year and acknowledges that the automatic withdrawals will not continue after the first year unless Member provides to the University thirty (30) days advance written request to continue the membership for another twelve (12) month term or Member converts it to the annual payment option.
C. **One Time Student Semester Payment:** Under this option, a payment of \$20 must accompany the signed Agreement. Students who desire to utilize the fitness center must pay this fee at the beginning of each semester in which they desire to utilize the center.

3. **TERM.** All memberships have a minimum term of twelve (12) months from the date of the Application unless otherwise indicated at the time of enrollment.

4. **MEMBERSHIP PRIVILEGES:** Members will be admitted to the fitness training room, the Labor Hall court, and shower/locker facilities. Membership also includes all group fitness lessons, classes, special programs and any other related activities sponsored and/or conducted by fitness center staff.

5. **RULES AND REGULATIONS.** Member acknowledges that the University operates under rules and regulations established for the safety and protection of patrons and agrees to be bound by them as well as by rules and regulations approved and posted or published by the University. Rules and regulations of the University, in effect from time-to-time, are incorporated into this Agreement by reference. Facilities, equipment, hours, service, regulations, and policies are subject to change, without prior notice, at the sole discretion of the University, and Member agrees to accept such reasonable change as a condition of membership. Member acknowledges that violation of any rules set forth in this agreement or as posted in the facilities at any time, the University may cancel this agreement and the right to use the facilities or obtain the services of the department. You will not be entitled to any refund of payments made. Any unpaid portion of the contract will become immediately due and payable.

6. **MEMBER'S RESPONSIBILITY/LIABILITY WAIVER.** Member recognizes that there are hazards connected with activities at the University Fitness center. Member is solely and personally responsible for utilizing his/her membership in a manner consistent with Member's individual fitness level and experience. Member knowingly and voluntarily assumes the risk of such hazards. Member agrees to defend, indemnify, and hold the University and its officers, agents, and employees harmless from and against any and all loss, injury, damage and expense incurred by reason of any claim or liability based upon personal injury (including death) or property damage arising out of the Member's use of the Fitness Center Membership.

7. **AGREEMENT.** This Agreement, Member's Application, the Membership Fee Schedule in effect from time-to-time, the Payroll Deduction Authorization, and the University's rules and regulations in effect from time-to-time constitute the entire Agreement between Member and the University.
