The SEVIS I-901 Fee

The SEVIS I-901 fee is mandated by Congress to support the program office and the automated system that keeps track of students and exchange visitors and ensures that they maintain their status while in the United States. Each student or exchange visitor issued an initial Form I-20 or DS-2019 on or after October 27, 2008, is responsible for paying this fee to SEVP. For more information, please go to www.fmj.fee.com.

Methods of I-901 Fee Payment

To make the payment, you will need a copy of your Form I-20. Currently there are several ways to pay the fee, but we suggest the following two methods of payment:

- Submitting and Paying online at www.fmjfee.com using credit/debit card
- Western Union Quick Pay

Method One: Paying online using credit/debit card

You can pay your fee by credit or debit card if you are submitting your form online at www.fmjfee.com. If you pay by credit or debit card, you should print out a receipt if you need one immediately and cannot wait to receive a receipt through the mail.

Method Two: Western Union Quick Pay

Nonimmigrant students and exchange visitors in more than 130 countries are able to pay the SEVIS I-901 fee using the Western Union Quick PayTM service located in their communities. There are five steps that you should follow:

Step One: If you choose this payment option, do not file the Form I-901 online.

Step Two: Print out a copy of these instructions, a copy of the Western Union form example (attached) and a copy of either your Form I-20 or Form DS-2019. Take a copy of each of these three documents with you when you visit your local Western Union Agent location.

Step Three: Go to a local Western Union Agent location and pay the SEVIS I-901 fee in the local currency.

Step Four: Review the Western Union form to make sure that the Western Union agent uses your name, your SEVIS ID number and your date of birth (not the information that appears on the Western Union form example). To find the nearest Western Union Agent locations go to http://www.paymentsolutions.com/agent.asp.

Step Five: After three business days, check on https://www.fmjfee.com/ to view your payment status. Once you see confirmation of payment on the https://www.fmjfee.com/ Web site, print out the confirmation page. The confirmation page serves as proof of payment of the SEVIS I-901 fee and can be used for a visa interview at a U.S. consulate and for admission at a U.S. port of entry.
